4. **LEVEL OF COMPETITION DESIRED:**

Open division for Saturday races. Team times will place you in a division for Sunday. The event will be limited to 20 teams, the top 12 teams will advance to Sunday and awards given for 1<sup>st</sup> thru 4<sup>th</sup> place in 3 divisions. Races will start at 9:00 A.M

5. **ENTRY FEE:**

( ) \$300.00 Registration Fee - Due on or before May 20, 2011  
After May 20<sup>th</sup> depending availability of space and practice time may be limited.

6. **TEAM COMPOSITION: Based on original entry.**

Teams are composed of 15 members, (10 paddlers and one drummer. Your team roster may include up to 15 participants. All divisions must have minimum of (4) female paddlers in the boat while racing. Drummer can be male or female.

7. **TEAM UNIFORMS:**

Each team is encouraged to wear a uniform, which may consist of matching tee shirts, hats, and/or shorts. The uniform could be imprinted with a logo, or just be the same color. Everyone must wear tennis shoes, sandals, or water shoes while racing. No boots, high heels, dress shoes, bare feet or flip flops. This will be strictly enforced.

8. **AWARDS:**

Awards will be presented immediately upon the completion of racing. There will be medals and awards for all three divisions, and the coveted "Spirit Award".

9. **LODGING:**

In town lodging will be limited on race weekend. However, other lodging is available within a 30-minute drive. We suggest that you contact the South Haven Visitors Bureau at (269) 637-5252 with questions on lodging. We also suggest you make reservations early.

10. **PRACTICE AND EQUIPMENT:**

All equipment, boats, paddles, life jackets, and stern paddles will be provided. We will begin to schedule practices in early May after entry fee is paid and subject to the volunteer's time.
